Academic Guidelines for Bachelor

July/21st, 2021. Passed by the 3rd Academic Affairs Meeting, spring semester, Academic Year 2020-2021.

- Article 1 This Academic Guidelines of the department are formulated in accordance with the “CYCU Regulation Governing the Determination of Each Degree’s Name, Conferral of Degrees, and Alternatives to Submission of a Master's Degree Thesis or Doctoral Dissertation”.
- Article 2 The Chinese and English names for the Bachelor's degree awarded by this department are as follows:

- Article 3 Please refer to Appendix I for the Table of Curriculum & Credit for Financial and Trade Law Group.
Please refer to Appendix II for the Table of Curriculum & Credit for Science and Technology Law Group.
- Article 3.1 Students in our department must complete a 2-credit course in "Legal Ethics" to graduate. This requirement also applies to students who are double majoring in Finance and Law.
- Article 3.2 Students in the Financial and Trade Law group must choose courses from either the "Financial Law Program" or the "Economic Law Program," totaling at least 12 credits, to graduate.
- Article 3.3 Students in the Science and Technology Law group must choose courses from either the "Intellectual Property and Competition Program" or the "Technological Innovation and Sustainability Program," totaling at least 12 credits, to graduate.
- Article 4 Full-year courses offered by this department must not be taken in reverse order.
- Article 5 Legal courses offered by departments other than this department, unless otherwise specified or approved by the Credit Exemption Committee of this department, shall not be counted towards the department’s graduation credits of this department’s students.
- Article 6 Students in the Bachelor's program of this department who are in their third year or higher may take compulsory courses one level higher than their current grade, with a maximum of two courses per semester. Exceptions to the above restriction may be granted in special cases upon application and approval by the department chair.
- Article 7 All other relevant matters not covered in these policies shall be governed by the “CYCU Academic Policies” and relevant regulations.
- Article 8 The regulations stipulated in Article 3-2 and Article 3-3 apply to undergraduate students enrolled from the academic year 2023-2024 onwards.

This guideline has been carried out in the review of the Academic Affairs Meeting. Any revision to this guideline will follow the same procedures.

Instruction :

I. The School Regulations :

- A. The "KQ-Sciences" and "IQ-Literature & Rhetoric" in the General Education Program are mandatory and must be completed during the freshman year. Regarding the "IQ-Literature & Rhetoric" courses, the Chinese Literature Classics should be taken during the first semester of the freshman year, while the Literacy and Rhetoric should be taken during the second semester of the freshman year."
- B. The General Education elective courses are divided into four categories: GQ-The Creator, EQ-Humanity, KQ-The Entire Creation, and IQ-The Individual Self. At least two credits must be taken in each category, with a total of 12 credits required to fulfill the requirement.
- C. The Computer Information Related courses, which must have a minimum of 2 credits, should include instructional content on programming design or programming language application. Additionally, at least one-third of the total teaching hours should be devoted to this topic. The courses aim to cultivate students' abilities in logical thinking, logical operation, and the use of technology for innovative learning.
- D. From the 101 academic years, undergraduate students are required to pass the English proficiency test recognized by the school to be eligible for graduation.
- E. From the academic year of 2014 onwards, fifth-year high school students are required to take additional 6 credits both for general education courses and professional courses.
- F. Students enrolled in bachelor's degree programs are required to take 2 EMI courses before graduation. 【Excluding English (I)&(II), English Listening and Speaking in Lab (I)&(II), Practical

English (I)&(II) and Business School Business English Conversation (I)&(II), Skills for English Language Testing (except for ALLS students)】

- G. The scope of other elective courses includes minor, double major, Interdisciplinary Course Program, Employment Program, Micro Program (including from other departments), PBL courses, MOOCs micro-credit courses (1 credit per course, up to a maximum of 6 credits), and Profession Self-Directed Learning (up to 2 credits).
- H. For the courses and grades issues, please consult the related regulations according to “CYCU Academic Policies”.

II. Graduation Regulations of the Department :

- A. The “Legal Ethics”, categorized as an extended humanities discipline, is a distinctive general education course offered by the College of Law. Students must complete this two-credit course for a bachelor's degree before graduation. Students who double major in the School of Law must also complete two credits in Legal Ethics (extended discipline of general education in humanities) before graduation.
- B. Students in the Financial and Trade Law group must choose courses from either the "Financial Law Program" or the "Economic Law Program," totaling at least 12 credits, to graduate.
- C. Newly admitted international students, including those from Hong Kong and Macao, should meet the education level equivalent to the eleventh grade of the Taiwan education system. International students mentioned above must take at least 12 additional credits during the study period. This includes six credits in general education courses and six credits in professional courses, with Introduction to Law (Two credits) as a compulsory course.

III. Regulations for Program Certification:

- A. This department offers five tracks: "Economic and Trade Law," "Technology Law," "Intellectual Property and Competition Program," "Technological Innovation and Sustainability Program", and "Judicial Practice Program."
- B. Completion of at least 12 credits in courses from the "Economic and Trade Law," "Technology Law," "Intellectual Property and Competition Program," or "Technological Innovation and Sustainability Program." Upon graduation, the department will award a "Professional Certificate," and there is no limit to the number of tracks that can be pursued.
- C. Completion of at least 16 credits in courses from the “Judicial Practice Program” will result in the award of a "Professional Certificate" upon graduation.
